WHAT IS STORMWATER?

Here in Byron, stormwater is rainwater and sometimes snowmelt that flows off of hard surfaces and into storm drains rather than being absorbed into the soil. Stormwater travels through the storm drains before being released into the nearest creeks and streams.

WHY WORRY ABOUT STORMWATER?

Stormwater pollution is one of the most significant sources of pollution to our waters. Stormwater from urban areas destroys stream life, pollutes drinking water, and has the potential to increase flooding and property damage.

Design Specifications

- All entries must be on white paper, with no more than 3 colors used.
- All entries must be no smaller than 3"x5" and no larger than 5" x 7".
- The logo should be suitable for many formats, such as use on websites, buttons, pens, etc.
- Wood, metal, glitter, or breakables are not allowed.

Contest Rules

- All participants must live within the city limits of Byron.
- Each entry must contain the City of Byron entry form (see reverse side and all necessary signatures).
- Submissions are due by November 1, 2015.
- All submissions must be the original artwork of the participant. Copyrighted clipart, images, or characters are prohibited.
- The winning participants will be notified by a phone call. Winning participants' photographs and logos will be posted on the City of Byron's website.
- Judges will be comprised of teachers, public works employees, and elected officials.
