Mayor and Council Minutes

The City of Byron Mayor and Council met in special session in the Council Chambers of the Municipal Complex. Mayor Michael Chidester, Council Members James Richardson, Rusty Adams, Michael Chumbley, Alan Dorsey and Chris Hodges were in attendance. City Attorney Brian Causey was absent. City employees that attended were City Clerk Telina Allred and City Administrator Tiffany Sandefur. There were no visitors or media at the meeting.
